Mark Brady, DVM, DACVECC - Lunch & Learn Hill's Pet Nutrition. Inc.



Dr. Mark Brady received his DVM degree from Purdue University in 1995. The following year he completed a small animal internship at Michigan Veterinary Specialists in Southfield, Ml. Dr. Brady spent the next eleven years working in the emergency and critical care department at a private specialty referral hospital in Overland Park, KS. He completed his emergency and critical care residency during this time in conjunction with the University of Missouri. Dr. Brady has been with Hill's Pet Nutrition Inc. since 2007 where he is currently the manager of the veterinary consultation service.

Sharon Center, DVM, DACVIM

James Law Professor of Medicine, Cornell University

Dr. Sharon Center completed her veterinary training at the University of California at Davis, followed by a rotating Internship in Small Animals and an Internal Medicine Residency at Cornell University. She joined the veterinary faculty at Cornell in 1983 and is currently the James Law Professor of Internal Medicine. She co-manages the Internal Medicine Service, provides didactic lectures in the areas of hepatobiliary, hematologic, and urinary disease to 3rd and 4th year veterinary students, trains Small Animal Internal Medicine residents, and conducts focused research in the area of hepatobiliary disease. Current research involves better histopathologic characterization of feline and canine liver disorders, breed related hepatopathies, and identifying toxic and infectious causes of liver injury. She has a long-standing interest in feline metabolism and energy utilization, and in the syndrome of hepatic lipidosis. She has authored numerous research manuscripts, clinical papers, and book chapters regarding liver disease in dogs and cats and often provides national and international lectures on liver disorders. She has received the Norden Teaching Award 2012 and Outstanding Woman Veterinarian by the Association for Women Veterinarians Foundation and was recently named Distinguished Alumni of the College of Veterinary Medicine at the University of California at Davis. Dr. Audrey Cook graduated from the Royal (Dick) School of Veterinary Studies, University of Edinburgh, Scotland, in 1989, The following year, she completed an Internship in Small Animal Medicine and Surgery at North Carolina State University College of Veterinary Medicine and then spent three years at the University of California at Davis College of Veterinary Medicine as a resident in Small Animal Internal Medicine. In 1994, she became a Diplomate in the American College of Veterinary Internal Medicine. In 1996, she achieved Diplomate status in the European College of Veterinary Internal Medicine. From 1997 to 2007, Dr. Cook owned a specialty referral practice in Newport News, VA before joining the faculty at Texas A&M. In 2013, she became a Diplomate of the American Board of Veterinary Practitioners (Feline Practice). She is currently Associate Professor in Small Animal Internal Medicine, with particular interests in endocrinology and gastroenterology.

Dr. Robin Downing is Hospital Director of The Downing Center for Animal Pain Management, LLC. She is the recipient of many regional, national, and international awards. Dr. Downing is a Certified Veterinary Pain Practitioner, a Certified Veterinary Acupuncturist, a Certified Canine Rehabilitation Practitioner, a Tui Na practitioner (Chi Institute), and is certified in canine medical massage (CSU) and animal chiropractic (IVCA). She was the third veterinarian to earn the Diplomate credential in the American Academy of Pain Management and the first veterinarian to earn the designation Certified Pain Educator from the American Society of Pain Educators, a second human pain management credential.

Michael Lappin, DVM, PhD, DACVIM

Professor of Small Animal Internal Medicine, Colorado State University

After graduating from Oklahoma State University in 1981, Dr. Michael Lappin completed a rotating internship in Small Animal Medicine and Surgery at the University of Georgia. After 2 years in a small animal practice in Los Angeles, he returned to the University of Georgia where he completed a small animal internal medicine residency and a PhD in Parasitology. Dr. Lappin became a Diplomate of the American College of Veterinary Internal Medicine in 1987. He is currently Professor of Small Animal Internal Medicine at the College of Veterinary Medicine and Biomedical Sciences at Colorado State University. Dr. Lappin studies feline infectious and immune-mediated diseases and has written over 250 primary research manuscripts and book chapters. His principal areas of interest are prevention of infectious diseases, the upper respiratory disease complex, infectious causes of fever, infectious causes of diarrhea, and zoonoses of cats. Dr. Lappin is on the editorial board of Feline Medicine and Surgery and Compendium for Continuing Education for the Practicing Veterinarian and is the editor of the textbook, Feline Internal Medicine Secrets. Dr. Lappin has received the Beecham Research Award and the Norden Distinguished Teaching Award. Dr. Lappin is the Kenneth W. Smith Professor in Small Animal Clinical Veterinary Medicine at Colorado State University and is currently the Assistant Department Head for Research. Dr. Lappin is the director of the "Center for Companion Animal Studies." The Center supports clinical research for faculty and students and utilizes only naturally occurring models of disease or research animals that can be adopted. He was selected to receive the European Society of Feline Medicine International Award 2008 for Outstanding Contribution to Feline Medicine, the Winn Feline Research Award in 2009, and was named an Oklahoma State University Distinguished Professor in 2010.

Susan E. Little, DVM, PhD, DACVM-Parasit

Professor & Krull-Ewing Chair in Veterinary Parasitology, Oklahoma State University



Dr. Susan Little is Regents Professor of Parasitology and the Krull-Ewing Endowed Chair in Veterinary Parasitology at the Center for Veterinary Health Sciences, Oklahoma State University, where she is active in veterinary parasitology teaching and oversees a research program that focuses on zoonotic parasites and tick-borne diseases. She earned her BS from Cornell University, DVM from Virginia Tech, and PhD in veterinary parasitology from the University of Georgia, and is board certified in veterinary parasitology through the American College of Veterinary Microbiology. She is a past-president of the American Association of Veterinary Parasitologists, co-directs of the National Center for Veterinary Parasitology, and is President-elect of the Companion Animal Parasite Council. Dr. Little has authored more than 100 publications on veterinary and human parasites and tick-borne disease agents. She is also recognized as an outstanding teacher and has been awarded two, Excellence in Teaching Awards from the National Student American Veterinary Medical Association (SAVMA).

Dr. Gary Norsworthy has been in private practice for over 40 years. Of those 40 years, 25 were spent in small animal practice and 17 were in feline practice. He is the owner of Alamo Feline Health Center in San Antonio, TX. In addition to practice, he lectures frequently on feline diseases and is the editor and major author of six feline textbooks. The most recent being *The Feline Patient, 4th Edition,* which is being or has been translated into Spanish, Portuguese, Japanese, Italian, Chinese, and Korean, and Nursing the Feline Patient, the first American feline textbook for technicians. His practice hosts externs from veterinary schools across North America and internationally. He is a charter Diplomate of the American Board of Veterinary Practitioners in the Feline Practice Category and an Adjunct Professor at the College of Veterinary Medicine, Mississippi State University and the Western University of Health Sciences. He was chosen for the 2009 Practitioners of the Year Award in the Medical Specialist category by the Texas VMA.

Mark Peterson, DVM, DACVIM

Dr. Mark Peterson graduated from the University of Minnesota in 1976, moved to New York City for an internship and medical residency at The Animal Medical Center (AMC), and then completed a post-doctoral fellowship in endocrinology and nuclear medicine at The New York Hospital-Cornell Medical Center and the Animal Medical Center. Following his training, Dr. Peterson stayed on as head endocrinologist at the AMC for over 30 years. In 2009, Dr. Peterson opened the Animal Endocrine Clinic in New York City, a specialty referral hospital devoted exclusively to the diagnosis and treatment of dogs and cats with endocrine disease, where he now cares for his endocrine patients. Over the last 35 years, most of Dr. Peterson's clinical and research efforts have been directed toward advancing our understanding of endocrine disorders of the dog and cat, especially hyperand hypothyroidism, diabetes mellitus, and adrenal disease. He has published more than 500 journal articles, book chapters, and research abstracts. With more than 500 lecture presentations to his credit, Dr. Peterson is a frequent speaker at veterinary colleges and scientific seminars both in the United States and abroad.

Veterinary Technician of Feline Internal Medicine, Texas A&M University

Ms. Paula Plummer has been at Texas A&M University since 2007, first working in the Small Animal ICU and then moving to the Feline Internal Medicine service in 2011. She graduated from Murray State College in Tishomingo, OK and has been a registered veterinary technician since 2000. In 2011, she received her veterinary technician specialty in emergency and critical care. Paula has spent most of her career in academia working in critical care or feline internal medicine teaching veterinary students tasks that will help them be better patient advocates when they graduate.

Jane Robertson, DVM, DACVIM - Lunch & Learn **IDEXX Laboratories**

Dr. Jane Robertson received her DVM from the Ontario Veterinary College at the University of Guelph in Canada in 1992. She worked in mixed-animal and small animal practice before completing a small animal internship at the same institution in 1994. Dr. Robertson completed her medicine residency at University of California, Davis, and became a Diplomate of the American College of Veterinary Internal Medicine in 1998. She practiced in a busy referral hospital before joining IDEXX as a Medicine Consultant in 2000. Dr. Robertson is currently Director of Internal Medicine for IDEXX Laboratories. She enjoys speaking about kidney disease, endocrinology, pancreatitis, and the clinical utility of real-time PCR.

Catharine Scott-Moncrieff, VET MB, MA, MS, DACVIM, DECVIM



Professor of Small Animal Internal Medicine, Purdue University

Dr. Catharine Scott-Moncrieff received her Master of Arts and Vet MB (Veterinary Medicine) degrees from the University of Cambridge in 1985. She completed an internship in small animal medicine and surgery at the University of Saskatchewan, Canada, and a residency and Master of Science degree in internal medicine at Purdue University. In 1989 she joined the faculty of Purdue University, where she is currently Professor of Small Animal Internal Medicine and Director of International Programs. She is a Diplomate of the American College of Veterinary Internal Medicine (small animal), the European College of Veterinary Internal Medicine (companion animal), and has a diploma in Small Animal Medicine from the Royal College of Veterinary Surgeons. She is the author or co-author of over 60 peer reviewed publications, 20 book chapters, and has lectured extensively both nationally and internationally. Her clinical and research interests include clinical endocrinology and immune mediated hematologic disorders.

Kenneth Simpson, BVM&S, PhD, DACVIM, DECVIM

Professor of Small Animal Medicine, Cornell University

Dr. Kenneth Simpson graduated from Edinburgh in 1984 and gained a PhD in Gastroenterology at the University of Leicester in 1988. Dr. Simpson hopped the pond for an internship at the University of Pennsylvania in 1989 and a medicine residency at the Ohio State University in 1991, then hopped back to the UK as a lecturer at the other Royal Veterinary College. He fled the hostile climes of Londinium in 1995 to join the faculty at Cornell University, Ithaca, NY. He is a Diplomate of the American and European Colleges of Veterinary Internal Medicine. He is a recipient of the National Phi Zeta and Pfizer awards for research, the BSAVA Bourgelat Award for outstanding contributions to the field of small animal practice, and the AVMF/AKC Career Achievement Award in Canine Research. He is a past president of the Comparative Gastroenterology Society. His research interests are centered below the diaphragm, with a focus on inflammatory diseases of the GI tract (including the pancreas and liver), host bacterial interactions in health and disease, and culture independent bacteriology.

Craig Webb, DVM, PhD, DACVIM

Associate Professor & Head of Small Animal Medicine Section, Colorado State University





Dr. Craig Webb is currently an Associate Professor in the Clinical Sciences Department at the Colorado State University Veterinary Teaching Hospital, where he is head of the Small Animal Medicine Section. Dr. Webb received his PhD in Neuroscience prior to completing his DVM degree at the University of Wisconsin-Madison. Dr. Webb completed his internship at Alameda East in Denver, CO, spent a year in private practice, and then went on to complete his Small Animal Residency at Colorado State University where he has been ever since. He is a Diplomate of the American College of Veterinary Internal Medicine and specializes in Clinical Gastroenterology. Along with Drs. David Twedt and Eric Monnet, Dr. Webb is an integral part of CSU CE courses in both Flexible Endoscopy and Laparoscopic Techniques. Dr. Webb presents annually at the ACVIM Convention and lectures throughout the United States and Europe on current topics in Small Animal Veterinary Medicine. Dr. Webb's research interests include stem cell therapy, antioxidants, and figuring out how to best educate veterinary students.

Protecting Cats from the Unexpected: Feline Vector-borne Disease Agents, Dr. Susan E. Little

Although risk is often underestimated, infection of cats with vector-borne disease agents, including heartworm (Dirofilaria immitis), bartonellosis (Bartonella henselae, other Bartonella spp.), and cytauxzoonosis (Cytauxzoon felis), is surprisingly common in many areas. Several recent studies have shown that consistent use of parasite control products can prevent transmission of these agents by preventing feeding of arthropod vectors or abrogating infections prior to development of disease. For example, application of imidacloprid/moxidectin heartworm preventive to cats prior to high challenge experimental infection with D. immitis prevented development of lung pathology and seroconversion in treated cats; cats wearing acaricidal collars with flumethrin are protected from tick-borne transmission of C. felis and development of cytauxzoonosis; and flea control using imidacloprid has been shown to block transmission of Bartonella spp. between cats. This presentation will review data from several studies that document the ability of parasite control products to prevent infection with common vector-borne pathogens in cats, thus supporting efforts to help cats live longer, healthier lives.

Emphasis will be placed on new clinically relevant information generated in the last 12-18 months and will include infectious agents associated with fever (Bartonella, hemoplasmas, Rickettsia felis, Anaplasma phagocytophilum), upper respiratory tract disease (FHV-1, FCV, Mycoplasma), lower respiratory tract disease (FIP, Toxoplasma, Bordetella), and diarrhea (Giardia, Cryptosporidium, and use of probiotics).

FRIDAY, SEPTEMBER 19, 2014

This lecture will address chronic vomiting, chronic diarrhea, and weight loss, all of which occur very commonly in cats and usually originate from disease in the small bowel. The attendee will learn how to recognize cats that need an abdominal ultrasound which usually leads to small bowel, liver, and pancreatic biopsies. Nearly 50% of these cats have chronic enteritis (usually IBD), and nearly 50% have lymphoma. Once the diagnosis if firmly made, the practitioner is in a position to treat both of these diseases. Dr. Norsworthy will reveal his approach to both and give instructions on how to communicate with the client before, during, and after the diagnosis is made. You should leave equipped with the knowledge and documents to diagnose and treat cats with this very common disease. You will find this new knowledge a game-changing event in your professional career.

Pancreatitis is increasingly recognized in cats and is often a real challenge to diagnose and manage. Cats are not small dogs and we have to challenge conventional DOGMA and pursue our inner CATMA. In this session we will also discuss - How good are fPL and ultrasounds, feeding in the face of pancreatitis, management of concurrent diseases (triaditis), and why you could consider bacterial infection in severe pancreatitis.

Lunch & Learn - Feline Urethral Obstruction: New Options, New Solutions to an Old Problem, Dr. Mark Brady Urethral obstruction (UO) is a potentially life threatening manifestation of feline lower urinary tract disease. This condition is thought

to be a sequel to feline idiopathic cystitis, so a review of this pathophysiology will be presented. Recommendations for management of this problem can be cost prohibitive for some clients leading to unwanted outcomes for our patients. The discussion will focus on recently published evidence to provide options in these challenging cases.

1:30 - 2:20 pm

6 Winning the Fight Against Hepatic Lipidosis, Dr. Sharon Center

Complex acquired metabolic deficiencies and dysregulations challenge survival in cats with hepatic lipidosis. This presentation will focus on evidenced-based approaches for hastened recovery from this devastating syndrome.

2:25 - 3:15 pm

G Are You Comfortable with Feline Constipation?, Dr. Craig Webb

Imagine if our human counterparts were faced with something as seemingly simple as constipation being a terminal disease, and in fact, for too many cats it is. Clinical cases of cats with constipation will be used to highlight important aspects of this condition, and the standard diagnostic work-up will be reviewed. Treatment strategies, both old and perhaps new, will then be presented and discussed. The clinician should walk away from this presentation with a new level of "comfort," or a few new ideas to try when faced with these frequently frustrating cases.

3:45 - 4:35 pm

Cholangiohepatitis: Emerging Evidence for Disease Pathomechanisms, Dr. Sharon Center

Investigation of oxidant injury, inflammatory signaling, and antimicrobial epitopes in feline cholangiohepatitis has broadened our understanding of its pathophysiologic mechanisms. This lecture will provide an overview of new information that better characterizes this complex feline syndrome.

3 Is There a Direct Link Between IBD, Cholangitis, & Pancreatitis in Cats?, Dr. Kenneth Simpson

Concurrent inflammation of the intestinal tract, liver, and pancreas is a relatively common occurrence in cats. In this session we will also discuss - is there a common stimulus driving inflammation in the intestinal tract, liver, and pancreas; could it be pathogenic bacteria or an immune-mediated disease; or could it possibly be the resident intestinal microbiota?

A Five Unique Feline Hepatic Syndromes, Dr. Sharon Center

This discussion will provide a synopsis of feline primary copper associated liver disease, cholelithiasis, hepatocellular carcinoma, hepatic amyloidosis, and biliary atresia.

3 Diagnosis & Management of Persistent Vomiting, Dr. Kenneth Simpson

A thorough and systematic approach is required to determine the cause of persistent vomiting. An integrated approach based on patient history, physical findings, clinicopathological testing, and diagnostic imaging will be presented. In this session we will also discuss - is Helicobacter a friend or foe, what antiemetic should I use, and when should I default to "Vitamin P?"

This discussion will highlight reasoned utility of these adjunctive therapies.
- (B) Chronic Diarrhea: What's the Cause?, Dr. Kenneth Simpson

A thorough and systematic approach is required to determine the cause of chronic diarrhea. An integrated approach based on patient history, physical findings, clinicopathological test, intestinal function testing, and diagnostic imaging will be presented. In this session we will also discuss - is it parasitic, immune, infectious, or neoplastic, and could diet be the problem?

PICU Boot Camp: What You Should Know on Day One! Ms. Paula Plummer What should technicians know when in the ICU? Your questions will be answered in this session. Some topics that will be covered are proper dosage calculations, CRI calculations, how to handle infectious patients, and how to deal with a burn out.

 - Managing Cats with Chronic Gastrointestinal Disease, Dr. Kenneth Simpson This presentation will review the differentiation and management of chronic enteropathies in cats. In this session we will also discuss how do I manage inflammatory bowel disease and how do I manage lymphoma?
 - Peline Friendly Handling & Restraint, Ms. Paula Plummer This session will discuss tips on how to make your practice feline friendly with new techniques for feline handling and restraint. There will be demonstration videos so you can see how to handle your patient safely. We will end with discussions on feline body language.

- 10:45 11:35 am (2) Stem Cell Therapy in Feline Chronic Enteropathy: In Theory Bench Top Research, Dr. Craig Webb The phrase "stem cells" conjures up a huge array of reactions and opinions, covering the gamut from moral repulsion to medical miracle. From this session, practicing veterinary clinicians will learn to discriminate between the many entries that fall underneath the "stem cell" umbrella, including important and distinct differences between the stem cells that fuel political debate, and those stem cells currently being offered as therapy for a myriad of human and veterinary diseases. The many potentially beneficial properties of mesenchymal stem cells will be covered, giving clinicians the foundation of information to more critically appraise the therapeutic use of this modality, both in theory and in practice.
 - 3 Diagnosis & Management of Feline Diabetes Mellitus, Dr. Catharine Scott-Moncrieff This lecture will focus on diagnosis and treatment of feline diabetes mellitus. Topics will include insulin choice, diabetic monitoring, and management of diabetes in the presence of concurrent illness. The lecture will also discuss alternative strategies for cases that do not respond well to the initial choice of insulin.
 - The Feline Diabetic: Understanding the Disease, Ms. Heather Lynch Many strides have been made in our understanding of the diabetic state in cats. This session will focus on increasing understanding of the causes and effects of diabetes in cats, why they are different from diabetic dogs, and give talking points to help technician's better support clients and DVMs when working with diabetic felines. Included in this session is a discussion of the important role annual care plays in the detection, and possibly prevention of this disease.
- 11:40 12:30 pm (3) Stem Cell Therapy in Feline Chronic Enteropathy: In Practice Clinical Application, Dr. Craig Webb Clinical cases will be used to highlight the history, diagnosis, and current treatment options commonly used for cats with chronic diarrhea (and/or vomiting). This will include a brief review of the evidence currently available to support these treatment choices (hence, the word "brief"). From there, the design, implementation, and results of a recently completed study using feline-derived mesenchymal stem cells for the treatment of client-owned cats with a chief complaint of chronic enteropathy will be detailed. The session will conclude by considering the stem cell therapy options currently available to the veterinary practitioner, leaving participants with a solid armamentarium when considering this therapeutic tool, or when asked to consider it by their clientele.
 - 3 Diabetic Ketoacidosis: Understanding Pathophysiology is Critical to Treatment, Dr. Catharine Scott-Moncrieff This presentation will focus on the cause of pathophysiologic derangements associated with diabetic ketoacidosis and how an understanding of the pathophysiology can improve case management.
 - The Feline Diabetic: Successful Management, Ms. Heather Lynch With good communication and teamwork between the client, the DVM, and the veterinary team, almost all diabetics will be managed successfully. This session will cover the important role the technician can play in the management of diabetic cats, with talking points, common barriers to communication or treatment, and common treatment protocols. Some case examples will also be presented.

- Lunch & Learn Diagnosis & Management of Feline Chronic Kidney Disease, Dr. Jane Robertson

This lecture will focus on the diagnosis and management of cats with chronic kidney disease (CKD). A new renal biomarker, symmetric dimethylarginine (SDMA), that has been shown to increase earlier than creatinine in cats with CKD will be introduced. The International Renal Interest Society's (IRIS) classification system for staging CKD in cats will be reviewed followed by a discussion of appropriate therapy that can slow progression of disease, improve clinical signs, and prolong life.

- Diagnostic Testing for Hyperthyroidism in Cats: More Than Just T4, Dr. Mark Peterson Over the past two decades, many advances have been made in the availability of tests that can be used to diagnose feline hyperthyroidism. However, all of the commonly-used tests have limitations, especially when evaluating cats suffering from nonthyroidal illness. This lecture will focus on an update on the diagnostic approach for the workup of cats with suspected hyperthyroidism. Since definitive diagnosis of this common disorder is not always clear-cut, this review concentrates on protocols used in the work-up of "occult" or problem cases, in which misdiagnosis can be common.
- Managing the Feline Diabetic: Picking a Protocol, Dr. Audrey Cook This lecture will review the factors to consider when starting a diabetic cat on insulin, such as frequency of administration, when and what to recheck, dietary considerations, and essential client education issues. The importance of creating a team approach and establishing appropriate expectations will also be discussed.
- The Unstable Feline Diabetic Patient, Ms. Paula Plummer Complications with your feline diabetic patient can be commonly seen in an emergency. These complications include diabetic ketoacidosis, hyperglycemic hyperosmolar syndrome, and insulin resistance. This session will focus on how to recognize these complications, treatment options available, and an overview of pathophysiology with each complication.

- What's the Best Treatment for Hyperthyroidism? Antithyroid Drugs, Surgery, Diet, or Radioiodine? Dr. Mark Peterson In cats, hyperthyroidism can be treated in four ways - surgical thyroidectomy, radioactive iodine (131-I), chronic administration of an antithyoid drug, or lifelong feeding of an ultra-low iodine diet. Each form of treatment has advantages and disadvantages, which must be considered when formulating the best treatment plan for the individual hyperthyroid cat. The treatment of choice for an individual cat depends on several factors, including the age of the cat, presence of associated cardiovascular diseases, other major medical problems (e.g., chronic kidney disease), availability of a skilled surgeon or radioiodine treatment facility, cost, and owner's preference. This lecture will review the pros and cons of each form of treatment, which should help the practicing feline veterinarian and owners decide which is really the "best" treatment for their cat.
- **13 Diabetes: Home Monitoring,** Dr. Audrey Cook This lecture will explore the reasons for encouraging home-monitoring of the feline diabetic and the benefits to the patient, client, and hospital. A step-by-step guide on getting started with home monitoring will be provided.
- What Every Technician Should Know about Feline Hyperthyroidism, Ms. Paula Plummer Occurrence of hyperthyroidism in feline patients is common. Every technician should understand basic physiology, clinical signs, different diagnostic methods, treatment options, and client education. This session will also include how to find that enlarged thyroid gland and how to understand our feline hyperthyroid patients so we as technicians can be better patient advocates.

O Hyperthyroidism & the Kidney: A Strategy to Slow Progression of CRD in Treated Cats, Dr. Mark Peterson Hyperthyroidism and chronic kidney disease (CKD) are both common disorders in older cats. About a third of hyperthyroid cats will have concurrent chronic kidney disease (CKD), but the CKD is commonly masked and azotemia may not develop until euthyroidism is restored. This lecture will focus on methods to help diagnose masked renal disease, as well as provide treatment strategies designed to prevent or slow the progression of CKD in these hyperthyroid cats.

Unlike the situation in dogs, naturally occurring hypothyroidism is extremely rare in cats. Most commonly, feline hypothyroidism is an iatrogenic complication associated with overtreatment of hyperthyroidism. Although early reports suggested that cats were resistant to hypothyroidism and did not require treatment, it is now realized that milder degrees of iatrogenic hypothyroidism are very common and that these cats may benefit from thyroid replacement therapy. This lecture will review the range of thyroid function tests available to aid in diagnosis of feline hypothyroidism and discuss its management.

- 10:45 11:35 am 🕓 Nutritional Management of Endocrine Disease in Cats, Dr. Mark Peterson When treating cats with endocrine disease, most veterinarians concentrate on the use of medical or surgical treatments that can be used to manage or cure the disease. Dietary issues are frequently ignored or not properly addressed. This is unfortunate, in as much as nutritional support should play an integral role in the successful management of feline endocrine diseases. The lecture will cover the two most common endocrine problems of cats seen in clinical practice (hyperthyroidism and diabetes mellitus) and discuss the way one can integrate nutrition into the management of these common feline diseases. Our goal is to use the cat's diet as a means to support their overall body health and metabolism and, therefore, help manage their underlying endocrine disease.
 - Management of Problem Diabetic Patients, Dr. Catharine Scott-Moncrieff This lecture will outline an approach to problems of insulin regulation in diabetic cats. The lecture will cover problems such as owner compliance, short duration of insulin action, insulin induced hypoglycemia, and insulin resistance. Case examples will be used to illustrate each problem.

- 11:40 12:30 pm (a) Managing Cats with Idiopathic Hypercalcemia, Dr. Mark Peterson Unexplained (idiopathic) hypercalcemia has been increasingly diagnosed in cats since the disorder was first described in the early 1990s. It is not clear what causes idiopathic ionized hypercalcemia or why it is becoming more prevalent in cats, but it is likely that the diet is playing a role in its pathogenesis. This lecture will review how I manage these cats with a stepwise approach that includes a change of diet therapy, followed by the use of glucocorticoids, bisphosphonates (alendronate), or both.
 - 3 Role of Concurrent Illness in Insulin Resistant Cats, Dr. Catharine Scott-Moncrieff Management of feline diabetes mellitus is sometimes complicated by underlying diseases that may cause profound insulin resistance. Lack of recognition of underlying disorders that cause insulin resistance results in poor glycemic control and decreases the likelihood of diabetic remission. This lecture will focus on the underlying causes of insulin resistance in cats, with special attention to two endocrinopathies (hyperadrenocorticism and acromegaly) that cause profound insulin resistance.

Lunch & Learn - What's New in Acute Feline Pain Management: Before, During, and After Surgery, Dr. Robin Downing Cats have been the "red-headed stepchildren" in the veterinary pain management world. An effective acute pain management plan for feline patients means anticipating when pain will occur, as well as anticipating how intense it may be. This lecture will focus on the clinical signs, diagnosis, and treatment of feline acromegaly. Indications for testing, interpretation of diagnostic test results, and approach to management will be discussed using case examples.
